- All merchandise must be of suitable quality for an arts & crafts fair. Management reserves the right to inspect all displays and exhibitor agrees to remove immediately any merchandise management considers inappropriate or misrepresented.
- Absolutely NO sales of "Side Pork" is allowed by the vendors. All other food item selling needs to be approved by event management prior to event.
- This is an outdoor show along the curb of Pennsylvania Avenue that borders the park. Vehicles must be moved to a designated parking area for vendors.
- Sellers are required to provide their own tents, tables, display materials and display their work during all the hours the show is open (11a.m. -5p.m.)
- Set up is allowed on Friday evening after 8 p.m. and security will be provided.
- Booths should be decorated in an attractive manner. Electricity is not available at all locations. Generator is accepted if fire code is followed.
- Registration is neither transferrable nor refundable. All sales are final
- All sales will be conducted between exhibitor and purchaser.
- All proceeds from management sponsored sales (i.e. admission, raffle, food sales, etc.) will be sole property of the management.

RELEASE, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT

The undersigned Vendor, in consideration of the SPF Promotions LLC extending permission to Vendor to use part of Pennsylvania Street between 3rd Avenue and the waterfront property in Sturgeon Bay, WI 54235, hereinafter the "Site," on June 10th 2017, for the purpose of displaying and selling arts and crafts in the course of the Side Pork Fest Arts & Crafts Fair, agrees to the following terms and conditions:

1. Vendor is informed and acknowledges that the City of Sturgeon Bay and SPF Promotions LLC have and assume no responsibility for the supervision of persons present upon the Site in the course of setting up, removing and participating in the Side Pork Fest Arts & Crafts Fair, to include conduct on the part of such persons which may result in damage, destruction, or theft of Vendor's goods.
2. Vendor will take all steps reasonably necessary to assure that the display and sale of Vendor's goods and all other conduct on the part of the Vendor, their agents and employees will not endanger the safety and welfare of any persons present upon the Site in the course of setting up, removing and participating in the Side Pork Fest Arts & Crafts Fair.
3. Vendor is informed and acknowledges that Vendor is not a named insured under any policy of liability insurance which may have been acquired by the City of Sturgeon Bay and SPF Promotions LLC and that liability insurance coverage is not provided to the Vendor by the City of Sturgeon Bay and SPF Promotions LLC.
4. Vendor will take all steps reasonably necessary to protect and safeguard the premises of the Site from damage, vandalism, extraordinary wear and tear, or other adverse effects caused by or arising out of the conduct on the part of the Vendor and the agents and employees of the Vendor in the course of setting up, removing, and participating in the Side Pork Fest Arts & Crafts Fair.
5. Vendor, on its behalf and on behalf of its agents, employees, and any and all persons participating in the display and sale of Vendor's goods in any manner, releases, forever, discharges, and agrees to indemnify and hold harmless the City of Sturgeon Bay and SPF Promotions LLC their officials, agents and employees, and their successors, individually and in their official capacity, from all claims, rights, causes of action, damages and demands whatsoever, including, but not limited to, all liability and judgments for personal injuries, known and unknown, property damage, costs, loss of services or expenses of any type, including attorney fees, which any person may have against all entities and affiliated persons, arising out of, relating to, concerning or in any way connected with use of the Site for the use of displaying or selling Vendor's goods, during the Side Pork Fest Arts & Crafts Fair 2017.
